D-6 Shared Youth Minister

To the Heart of Texas Mission Center Conference:

Whereas, Heart of Texas Mission Center (“HTMC”) is devoted to serving our youth in the mission center and to enhancing the opportunities available to our youth, and

Whereas, Coastal Bend Mission Center (“CMBC”) is seeking to employ a full-time youth minister to work with its youth and has approached HTMC to determine if it would be beneficial to join together to employ a youth minister to work with the youth throughout the State of Texas, and

Whereas, HTMC's leadership team believes that the opportunity should be explored and during 2023 to determine whether HTMC should participate in the employment of the youth minister to work with the youth of HTMC.

Now therefore, be it:

Resolved, that HTMC is authorized to explore, in conjunction with CMBC, the potential employment of a shared full-time youth minister on terms and conditions to be agreed to by the respective mission centers, and further

Resolved, that the leadership team of HTMC is authorized and directed to determine in their discretion the terms and conditions on which HTMC would participate in the employment of the full-time youth minister to work with the youth of CMBC and HTMC and is authorized and directed to implement the terms and conditions of the employment arrangement with the understanding HTMC will bear no more than one-third (1/3) of the aggregate costs and expenses for the youth minister and receive approximately the same percentage of the person's time and efforts for the youth of HTMC, and further

Resolved, if the leadership team of HTMC determines in their discretion an appropriate structure and related terms and conditions for HTMC's participation in that employment has been achieved, HTMC's leadership team is authorized and directed in conjunction with CBMC to conduct a search and employ a candidate to fill the youth minister position with a term not to exceed a three-year contract commencing as early as 2023, and further

Resolved, that HTMC’s proportionate share of employee costs, expenses and reimbursements are authorized to be funded from HTMC reserves for 2023 and, in subsequent years, from the HTMC operating budget.

Heart of Texas Mission Center Conference Minutes
Saturday, October 30, 2021 @ 2:00 p.m.
[Hybrid Conference]

Mission Center President Joe Postnikoff welcomed all to the Heart of Texas Mission Center conference and called the meeting to order at 2:00 p.m. The conference opened with the congregation singing CCS 624 “*God of Grace and God of Glory*”. Scott Bushman offered the invocation.

Greetings from the World Church

The Chair then recognized Apostle David Nii who offered greetings on behalf of himself and World Leadership.

Review of Conference Online Voting Procedures

The Chair thanked Ray Stanton for serving as the conference ZoomMaster and recognized Ray to provide insight into the online voting procedures to be observed during the business session. After providing information regarding the online voting procedures, Ray returned the chair to Postnikoff.

Commonly Used Parliamentary Actions

The Chair informed the conference that there was, on page 5 of the conference packet, a list of commonly used parliamentary actions. The Chair also informed the conference that, if anyone was unsure as to how to participate, they should just make a parliamentary inquiry with The Chair.

Approval of Minutes

The Chair noted the minutes of the October 24, 2020 mission center conference were previously published on the mission center website and distributed through the mission center email chain. They are also printed on pages 19 through 23 of the Conference Bulletin. There being no offered changes or corrections, the minutes were declared approved as submitted.

Mission Center President’s Report

The Chair provided a year in review with respect to 2021 and highlighted remaining scheduled events for the year. The Chair also previewed upcoming events planned for 2022

Mission Center Financial Officer’s Report

The Chair called the attention of the conference to the Mission Center’s YTD Operating Fund Income and Expense Statement located on pages 10 and 11 and the 2020 Audit Report located on pages 12 through 15 of the Conference Bulletin. The chair recognized Chris Beck for a brief statement concerning 2020/2021 finances.

Chris Beck presented the Heart of Texas 2020/2021 financial statements and reviewed Balance Sheets, Receipts, Disbursements, Undesignated, Equipment and Operating Reserve Funds.

Mission Center Invitation Support Minister’s Report

The Chair called on the Katie Barber the Mission Center Invitation Support Minister for a report and Katie provided a preview of things to come in 2022.

Sionito Campgrounds Association Report

The Chair called attention to the Sionito reports found on pages 24 through 35 of the Conference Bulletin. The Chair then recognized Nick Sanders to make a report to the conference concerning the Sionito Campgrounds Association. Nick highlighted the challenges and successes of the 2021 camping season, the response to COVID-19 as well as recent improvements to the campgrounds.

Sionito Camping Committee Report

The Chair called attention to the 2020 Camping Committee Audit Report found at pages 16 through 18 and the Camping Committee Report for the 2020 camping season which is found on page 37 of the conference bulletin.

The Chair noted the 2021 camping season provided for in-person camps and that while attendance was down somewhat from pre-COVID years, the Camping Committee was pleased with the final results.

Other Reports and Recognitions

The Chair called attention to the 2021 calendar found on pages 40 of the conference bulletin. The Chair then called attention to the publication of the Mission Center Leadership Team membership, Support Team membership, Boards and Committees memberships, as well as congregation pastors and financial officers found on page 36 through 39 of the conference bulletin.

The Chair then recognized Kerbi Elsenbroek and Kyla Thutchley as the outgoing pastors of Bridges Congregation; Brian Roberson as the outgoing pastor of McKinney Congregation; Charlotte Shanks and Vernon Glaser as the outgoing pastors of Waco Congregation; and Jim Price as the outgoing pastor of Willow Creek Congregation.

The Chair also extended thanks to all pastors, pastoral teams and financial officers in the mission center for the work they do in their congregations.

Joe Postnikoff yielded the Chair to David Nii to conduct the sustaining of mission center officers.

GENERAL ORDERS

Mission Center Leadership

A-1: Sustaining of Mission Center Officers for 2021

Nii then called up Item A-1 and Nick Sanders made the motion to approve the resolution. It was seconded. The Chair then read a letter from the First Presidency appointing Joe Postnikoff as Heart of Texas Mission Center President. A vote was taken and the appointment was sustained. The Chair then read the letter from the First Presidency appointing Chris Beck as Mission Center Financial Officer. A vote was taken and the appointment was sustained. The resolution was then voted on as a whole and motion passed.

A-2 Sustaining of Mission Center Leadership Team

Nick Sanders made the motion to approve the sustaining of the Mission Center Leadership Team for the 2021 term. It was seconded. There was no discussion. A vote was taken and the Leadership Team was sustained.

A-3: Sustaining of Mission Center Council

The Mission Center Council includes the Leadership Team, Pastors, Co-Pastors, Congregation Financial Officers of the congregations and emerging congregations of the mission center and other individuals appointed by the Mission Center President. Ray Stanton made the motion to sustain the Mission Center Council. The motion was seconded. A vote was taken and motion sustained.

A-4: Sustaining of Mission Center Recorder

The Chair announced that Kathie Moss has previously served in this position and had asked to be released. A replacement has not yet been identified.

David Nii yielded the Chair to Mark Minton.

Camp Sionito Representatives

B-1: Sustaining of Camping Committee Members

The Chair called attention to Item B-1, the sustaining of the Camping Committee members appointed by the Mission Center Presidents of Heart of Texas and Coastal Bend Mission Centers as well as the affiliated congregations of the Mexico-Texas Mission Center, and approved by those conferences. Katie Barber, Jamie Beck and Bobbie Price have all been appointed to represent the Heart of Texas Mission Center for the term of September 1, 2021 through August 31, 2022. Nick Sanders made a motion to approve this resolution. The motion was seconded. There was no discussion. A vote was taken, and the motion was sustained.

B-2: Election of Directors to Board of Directors of the Sionito Campgrounds Association

The Chair called for the election of directors to the Sionito Campgrounds Association. The election is to fill two positions, each serving three-year terms (September 1, 2022 – August 31, 2025) on the Camp Sionito Board of Directors. A list of current board members is found in the conference bulletin.

The terms of office for Austin Hall and Linda Rose will expire Aug. 31, 2022. The conference elected two board members to fill these vacancies. Mike Thrutchley nominated Linda Rose for the 1st 3-Year Term position and she was approved. Mike Thrutchley nominated Tim Everett and Chris Beck nominated Austin Hall for the position. A vote was taken and Tim Everett was elected.

Mark Minton yielded the Chair to Joe Postnikoff.

Mission Center 2022 Budgets

D-1, D-2, D-3, and D-4: 2021 Endowment, Equipment, Undesignated Earnings, and Operating Reserve Fund (respectively)

The Chair called attention to items D-1, D-2, D-3, and D-4. These resolutions pertain to funds not covered in the operating fund budget. With no objection, the conference would consider these four resolutions as a whole. No objection was made. A motion for approval of all resolutions was made by Bobbie Price and there was a second. A vote was taken, and the motion was approved.

D-5: 2022 Mission Center Operating Fund Budget

The Chair recognized Chris Beck who made a motion to approve the Mission Center Operating Fund Budget which was found on page 10 of the conference bulletin and the motion was seconded. The Chair then recognized Chris Beck to present the Operating Fund Budget for 2022. There was no debate or discussion. A vote was taken and the motion was approved.

D-6: 2020 HTMC Internal Audit Report
